Minutes of Swaffham Prior Parish Council Meeting held on Thursday, 9th January 2014 at 7.30pm Village Hall.

- 1417. <u>Apologies for Absence:</u> CCC – Cllr David Brown ECDC – Cllr Allen Alderson David Almond *(family bereavement)*
- 1418. <u>Members' Declaration of Interest for Items on the Agenda + Requests for</u> <u>Dispensations</u>: None.
- 1419. <u>Public Participation:</u> No matters raised.
- 1420. <u>Approve and Sign Minutes of Parish Council Meeting 12th December 2013:</u> Minutes agreed and signed as a correct record. *Proposed: Geoffrey Woollard. Seconded: Peter Hart. Agreed unanimously.*
- 1421. Reports:

CCC Matters: *Clerk read out written report provided by Cllr David Brown*. Min.ref.1405: GW referred to the discussion at the December meeting about the Cromwell Museum confirming that he had subsequently written a letter and received a reply and concluded that the point had been made and he had no further comments.

ECDC Matters: No report.

1422. Matters Arising from Previous Minutes (for information only):

Water leak at Cemetery - Min.ref.1409: SKP reported that it had not been possible to inspect due to the poor weather but referred to previous estimates of water usage and concluded that due to the high volumes recorded it was not feasible that there was not a leak. He suggested that as previously agreed an investigation by a suitably qualified company should be carried out once the weather improved. In the meantime, the water supply was turned off.

Footpath – Swaffham Prior to Swaffham Bulbeck: PH referred to email from Ramblers' Association summarising their discussion with CCC and confirming that there was insufficient evidence and the landowner would not permit the reopening of this footpath and as such there was nothing further that could be done.

Community Land Trust – Min.ref.1410: A reply was received from SLCC (email – 24/12/13) – summary:

- PC corporately can be a Director of the Company. *GW raised concerns about the reference to a company and whether the PC corporately could be a Director of a company.*
- If Clerk acts like a Director of the CLT, she would need to be sure the PC was indemnifying her against all errors, misjudgements and similar insurable risks. *Clerk to follow up with insurance company.*
- The Clerk and PC needed to be clear about when the Clerk can vote according to what she thinks best and when (if ever) she needs to get a resolution of the PC

before voting in a CLT Board meeting. A clerk with a restrictive or restricted brief would be in a very difficult position. *There followed discussion and it was agreed that the Clerk should vote as she sees fit on any subject raised but have the option to refer back to the PC if she felt it was needed.*

• When the CLT company has been formed, the PC should not keep any of the company's money in the PC's bank account. *Clerk to check on whether an account for the CLT has been opened.*

• The PC would need to be aware of any conflicts of interest. *This was noted*.

Following further discussion the Clerk was to meet with Emma Fletcher and clarify the points raised and whether she would be a Company Director or Trustee.

1424. Confirmation of Budget/Precept for 2014/15:

GW put forward a motion to amend the Precept reducing it by £500. This was not seconded. Following discussion the majority agreed to keep the Precept figure at £14,500. *Proposed: Steve Kent-Phillips. Seconded: Peter Hart. Vote taken*-7 *in favour, 1 against (GW).*
