## 1493. Approve and Sign Minutes of Parish Council Meeting – 10<sup>th</sup> April 2014:

The minutes were agreed and signed as a correct record. *Proposed: Geoffrey Woollard. Seconded: Steve Kent-Phillips. Agreed unanimously.* 

#### 1494. Reports:

CCC Matters: *Cllr David Brown reported to the meeting*.

GW asked DB why the future of the Cromwelll Museum was being considered by the Highways and Infrastructure Committee. DB explained that libraries are the responsibility of that committee.

ECDC Matters: Cllr Allen Alderson reported to the meeting.

GW asked AA where it was proposed to reduce the number of councillors would people have the power to choose. AA replied.

#### 1495. Matters Arising from Previous Minutes (for information only):

Min.ref.1543: Passing Place, Station Road: Following a site inspection carried out by CCC's Local Highways Improvement team, a plan showing the proposed location for the passing place - on the left-hand side just before the bridge - was circulated for councillors to consider. JC & SKP commented that the parking issues around the football ground had improved.

## 1496. Correspondence for Circulation/Consideration (*Appendix 1*):

CCC: *LHI – plan for passing place*. Following on from discussion under 'Matters Arising', the proposed location was agreed as the best option. Also, a requirement of CCC's funding for the project was a Parish Council contribution of 10% towards the cost of the work. This was unanimously agreed. Clerk to confirm with CCC.

1497. Consideration of Planning Application for 5 Rogers Road – works to convert an extension to an existing dwelling as follows; 1) raising of roof on existing rear extension to gain usable room heights; 2) first floor addition on top of existing ground floor extension totaling 12.7m. Ref: 14/00235/FUL:

JC put forward motion to consider the following planning application. This was unanimously agreed.

# 1498. <u>Consideration of Planning Application for 26 Green Head Road – two storey rear extension:</u> Ref: 14/00402/FUL.

This application was considered to be over-large for development area and could overlook neighbouring properties. (GW abstained). Clerk to forward comments to ECDC.

#### 1499. Review and Approval of Asset Register:

Value of assets increased to £544,100 from £425,714. Summary below:

- Village seats (including new ones) £2,000.

Amendments were made and unanimously agreed.

## 1500. Memorial to Women's Land Army – insurance and maintenance:

It was agreed that the PC would be responsible for the future insurance and maintenance costs for the memorial. *Proposed: Geoffrey Woollard. Seconded: Steve Kent-Phillips*.

The Clerk told the meeting that Sylvia Short had offered to pay for a plaque to be added to the memorial to note the date of the unveiling. This was agreed as a good idea. Clerk to speak further with Prince family and SS.

## 1501 <u>Cemetery Maintenance:</u>

Following a complaint received about the overflowing bin and the spoil heap in the cemetery, Andrew Camps confirmed he had burnt off the rubbish in the bin. Other maintenance items were discussed.

AC asked to purchase visible ground markers and approximately 30 engineering bricks to mark out new plots in the cemetery. *This was unanimously agreed.*Action: AC

### 1502 Memorial Seat to the Late John Norris:

The Secretary to The Parochial Charities confirmed to the clerk that they were to go ahead with the purchase of a seat and requested to locate this on the eastside of Coopers Green. This was unanimously agreed.

It was also agreed that rather than contribute to the cost of purchasing and installing the seat, the Parish Council would take responsibility for future insurance and maintenance costs. *Proposed: Steve Kent-Phillips. Seconded: David Almond. Unanimously agreed.* The Clerk was to write to The Parochial Charities and confirm.
