

**Minutes of the Swaffham Prior Parish Council meeting held on Thursday 14th July 2022
at 7.30pm in Swaffham Prior Village Hall.**

43/22-23 To receive apologies for absence and to approve reasons for absence where appropriate.

44/22-23 Members' declaration of interest for items on the agenda and requests for dispensations

SKP proposed a transfer of £4500.00 from the savings to the current account; PH seconded, passed unanimously.

52/22-23 To approve a request for a grave marker
SKP proposed that the request for a grave marker be approved; seconded SG, passed unanimously.

53/22-23 To agree a response to Lucy Frazer MP invitation to a tour of the Houses of Parliament.

Action: The Clerk to reply confirming the PC's interest and asking for possible dates.

54/22-23 To discuss options for replacing the playground equipment.

Options were circulated and considered from Wicksteeds and NGFplay. Kompan were unable to visit the playground before the end of July.

SKP proposed that the PC accept the quote from Wicksteeds for a Marco Polo unit and moving of the spring daisy; seconded PH, passed unanimously.

Action: PL to apply for grants for funding.

55/22-23 To agree a response to the Draft Fenland Transport Strategy, Draft Huntingdonshire Transport Strategy and/or the Draft Cambridgeshire's Active Travel Strategy via the CCC Transport Strategy Stakeholder Engagement Survey.

In the absence of further information from DG and in light of the deadline being passed, this item was dropped.

56/22-23 To agree a letter to the allotment renters regarding water use.
SKP proposed a letter to all allotment renters and the owner of the horses, restating that the filling of the horses' water trough is to take place in an evening (after 6pm) only, and that no unattended hosepipes are to be left on at any time, as stated in the allotment agreement; seconded PL, passed unanimously.

Action: Clerk to write as above.

57/22-23 To appoint representatives to the working group for B1102 improvements
SKP nominated DG (subject to DG's agreement).

The Clerk volunteered to attend as well.

58/22-23 Clerk's Report

The Clerk had attended the ACRE talk on affordable housing and noted that Cambridgeshire ACRE would be a good contact if more affordable rural housing schemes were planned for the village.

59/22-23 Parish Councillors' Reports

- a) SG noted a comment from a member of the public that the wilder area of the cemetery was attractive. SG also asked that a notice be put up in the cemetery pointing out the new location of the bins, next to the gates.
- b) PL commented that the increase in commercial flights over the village was due to a new flight path.
- c) PH noted that two of the traffic calming posts on Mill Hill had been destroyed.

- d) SKP noted that the website had been inaccessible for 4 days but was now up and running again

Clarification was asked for regarding the aim of the A-B1102 working group – it was explained that this was to reduce the speed limit through the village.

It was noted that the Pound needs attention as it is increasingly weed-filled.
