#### **1. INTERMENTS (excluding all labour charges)**

| a) For any interment in a grave of a body of a person whose age at the time of death exceeded 12 years.                | £175.00        |
| b) For any interment of a non-viable foetus, stillborn child, or a child whose age at death did not exceed 1 month.    | Free of charge |
| c) For any interment of a child whose age at the time of death exceeded one month but did not exceed 12 years.         | £100.00        |
| d) For the interment of cremated remains in a grave already purchased.   | Free of charge |
| e) For the interment of a coffin or casket over 6ft 10in in length or more than 3ft wide in a grave already purchased. | £200.00        |

#### **2. EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES**

| a) For the exclusive right of burial for 100 years in an earthen grave 9ft by 4ft.                     | £225.00 |
| b) For the exclusive right of burial for 100 years of cremated remains in an earthen grave 2ft by 2ft. | £90.00  |
| c) For the transference of ownership of the exclusive right of burial to a new owner                   | £25.00  |

#### **3. MONUMENTS, GRAVESTONES, TABLETS AND MONUMENTAL INSCRIPTIONS.**

| a) For the right to erect and/or maintain grave markers on a grave for 100 years, once the original exclusive right of burial has expired. | £25.00 |
| b) For the right to erect or place on a grave or vault in respect of which   |        |

| (ii) A <b><u>FLATSTONE</u></b> not exceeding 6ft by 3ft  | 50.00  |

| (iii) Inscribed memorial vase not exceeding 12 inches in height   | 30.00 |
| c) For the right to erect or place on a <b><u>CREMATION PLOT</u></b>  |       |

| The fees indicated for the various heads of this part include the first inscription. For each <b><u>inscription after the first</u></b> , a fee is payable of ..... | 50.00 |

The fees and payments set out will be quadrupled where a person is not an inhabitant or parishioner of the Parish of Swaffham Prior, or where neither of the parents of a still-born child is such an inhabitant or parishioner.

The term inhabitant shall be interpreted to include a person who at the time of death or some time during the six months immediately prior to death normally resided in the Parish of Swaffham Prior, or in special circumstances at the discretion of the Parish Council.

The above fee table and regulations governing the use of Swaffham Prior Cemetery was passed by resolution of the Parish Council on the 12<sup>th</sup> December 2019 and these changes are to be levied in every case.
